This months examinations have 278 entries with participation of 160 students. Approximately: 44% are Tap - 30% Hip Hop - 8% Ballet - 6% Jazz - 6% Contemporary - 6% Boys. Of the 390 students approximately 38% are pre schoolers and 15% are 5-7 year olds. The remaining 47% are students practicing all the exam syllabus for Tap, Hip Hop, Ballet, Jazz and contemporary. (These are approximate numbers only).

A wonderful array of costumes are part of the package and there is also the opportunity to take on the retail sales of ballet and tap uniforms and all related dance accessories.

For an additional cost you may also be interested in the purchase of the studio which the school is running from which is fully equipped with wooden in lay flooring, mirrors and ballet barres. Should you wish to relocate the existing roll of students to an existing school this is a great option also.
